## EOI for Submission of Project Proposals under (DDU-GKY 2.0), Rajasthan

Rayasthan Skill and Livelihoods Development Corporation (RSLDC) invites applications from the interested Project Implementation Agencies (PIAs) under DDUGKY 2.0 scheme to allot target of skilling of 7957 candidates (Including 500 candidates for Captive employers and 400 for Persons with Disabilities Candidates), rural poor youth for the financial year 2025-26. Interested Project Implementing Agencies (PIAs) may apply to implement a dedicated project under the Captive Employer model for Category-A agencies, with a target of 500 rural youth. Captive Employer PIAs must be empanelled as per Notification No. 18/2020, dated October 6, 2020, issued by the Ministry of Rural Development (MoRD). Guidelines. and Standard Operating Procedures (SoP) of a Captive Employer would be applicable of Captive projects. Interested Project Implementing Agencies (PIAs) may apply to implement a dedicated project for Persons with Disabilities (PWDs), with minimum target of 400 rural youth reserved under the PWD category. Guidelines as notified vide notification no. 43/2017 would be applicable in PWD projects.

NABARD Consultancy Services (NABCONS) has been empanelled as Appraisal Agency under DDUGKY 2.0 in Rajasthan. Interested PIAs having PRN allotted from MoRD, may apply online on the portal of MoRD i.e. https://kaushal.rural.gov.in along with the non-refundable application fee of Rs 25,000 /- for initial Screening in favour of RSLDC. After clearing/Passed the initial screening project applied agencies will be intimated to deposit Rs. 1,25,000 excluding GST (18%) for Quality Appraisal

The Appraisal of DDU-GKY 2.0 project has to be conducted through the IT platform provided by MoRD only An account detail for initial screening fee submission is (Name of Account Rajasthan Skill and Livelihoods Development Corporation, Account No. 40676605192, IFSC Code- SBIN0032014 Bank and Branch State Bank of India, RTO, Jhalana Doongari, Jaipur). Applicant PIA should read the guidelines and Standard Operating Procedures (SOP) carefully before filling up the application form. The Guidelines and SoP are available on the website of MoRD (DDUGKY).

Under DDUGKY 2.0 project, agencies that can train and place candidates according to the skill gap existing in different sectors are encouraged to apply. It is to be noted that the agencies applying for the DDUGKY project shall bear the expenses as detailed above for undertaking the project appraisal by agency on behalf of RSLDC.

- In order to be eligible to apply for a project, an entity should be: -
- A. Registered under Indian Trust Acts or any State Society Registration Act or any State Cooperative Societies or Multi-State Co-operative Acts or the Companies Act 2013 or the Limited Liability Partnerships Act 2008, or SHGs and its federations namely Cluster Level Federation/Block Level
- B. A Government or semi-government organization at the State and National Level
- C. NGOs must be registered with NITI Aayog's Darpan Porta Signature valid

  D. Be more than three years old at the time of application exception at the time of application exception.

- D. Start-ups for Skilling recognised by Dept of Industrial Policy & Promotion, Ministry of Commerce & Industry, Gol.
- 3. The following shall not be eligible for applying in DDU-GKY: -
- A. Existing PIAs who got DDU-GKY Projects sanctioned and have recovery proceedings going on
- B. Existing PIAs who were unable to place 50% of trained candidates under DDU-GKY.
- C Skilling agencies having officials at key managerial personnel as per accounting standard 18, who were earlier associated with defaulting PIAs against whom recovery proceedings were initiated due to default.
- D. Sister concern/subsidiary of any organization against whom default action for recovery of funds initiated
- E. Skilling Agencies having Directors involved in agencies that defaulted earlier with DDU-GKY. A provision shall be built into the system for validating the DIN of directors of the applicant organization through MCA database.
- F. Skilling Agencies blacklisted by Government.

- 4. The Appraisal of the proposal shall be carried out with the following conditions:
- A. All agencies (Existing DDUGKY PIA and New agency) must generate the new PRN through https://kaushal.rural.gov.in for DDUGKY 2.0 under Categories A, B, C, and D.
- B. Project Implementing Agencies (PIAs) are required to strictly follow the DDU-GKY Guidelines 2.0, Standard Operating Procedures (SOP), Notifications/Order as notified by the Ministry of Rural Development (MoRD) and Rajasthan Skill and livelihoods development Corporation (RSLDC) from time to time. This includes any updates or modifications to the guidelines and procedures.
- C. Applicant agency can apply for any districts from any category. However, it is encouraged that successful agencies opt for Aspirational, Tribal Area Districts, and Border/Desert districts in target allotment and format available at Annexure-B. Agency has to fill three preferences from each category as per format available at Annexure A, which must be uploaded / submitted with eligible documents at the time of Quality Appraisal. Priority will also be given to selected projects that have applied for Special category (Person with special ability/ Manual Scavengers/Women Headed Households)in target allocation. The information in annexure A is only for information purpose. Actual allotment across Aspirational /Tribal/Desert/Other districts may or may not be as per the preferences given in annexure A.
- D. Priority will be given in target allotment to those successful agencies who opt the courses from Gems & Jewellery, Aerospace & aviation, Hydrocarbons, Food processing, green jobs, Artificial Intelligence, Leather & Agro based, IT (Digital Marketing, Data Science)& AI, Cloud Computing, AI & ML, Cyber security, Solar installer and repairing, tourism and hospitality, EV vehicle and batteries, Rubber, Chemical & Petrochemical sector.
- E. Projects applying under DDUGKY 2.0 RSLDC have to comply the sub-category targets given in the table below:

G DDUGKY 2.0 allows Training Course duration minimum of 3 months with 576 hrs. of Training (Domain 396 hrs. and non-Domain 180 hrs.). In cases where the no. of domain hours is less than

- 396 hrs., then relevant independent NOS/micro-credential of that sector shall be allowed to be added to meet out the minimum required training duration(Hours). If the duration of Domain hours is more than 396 hrs, Clubbing is not permitted (Ref. SoP DDUGKY 2.0 page no-448/C). Maximum domain hrs adopted by PIA should not be more than 700 hrs. Latest updates in trades are available at Trade Master in Kaushal Bharat Portal.
- H. The core outcome of DDU-GKY program shall remain placement (minimum 70%) be it with Wage Employment (minimum 50%), Self Employment (maximum 20%) or Gig Employment. Placement (Wage/self-employment& Gig employment) shall be considered based on the verifiable proofile Bank Statement showing receipt of Monthly Salary through bank transfer in case of wage employment, Service Charges in case of Gig Employment and Income in case of Self Employment Placement in self employment shall be assisted through credit linkage by Banks (Ref. Guideline 2.0 page no-35)
- 1. Placement is to be made in the job roles for which domain training is provided. DDU-GKY shall be actively debarring cross placements in sectors where skill training acquired is not being used. However, if a candidate is placed in a sector that is different from the one in which they received training under the Deen Dayal Upadhyaya Grameen Kaushaiya Yojana (DDU-GKY), the salary she/he receives should be at least 20% higher than the minimum wage of semi-skilled category or rupees 10,000/-, whichever is higher applicable at the employer's location, as notified by the relevant department. This provision ensures that the candidate is adequately compensated for their skills and experience, even when employed in a different sector than the one they were trained (Ref. SoP DDUGKY 2.0 page no-481)
- J. Minimum Remuneration per candidate per month within India of 10,000 or Minimum Wages of location of Employment of semiskilled category whichever is higher and Minimum Remuneration per candidate per month outside India is Rs. 25000 per candidate. (Ref. SoP DDUGKY 2.0 page no- 524)
- K. Target allocation details:
  - a. Target Allocation in Category 'A' (Captive Employer)- Top2 Agencies (as per highest quality score) will be selected under this category based on quality appraisal for allotment of 500 training target. In case if any target remains unassigned/surrendered/forfeited or selected top agencies are unable to take on /complete the targets, the PAC may select agency next in ranking based on QA score and availability of training targets.
  - b. Target Allocation in dedicated PWD Projects-Top 3 Agencies will be selected based on quality appraisal (as per highest quality score) for allotment of 400 Training target. A separate list from B,C and D categories PIAs (who applied for PWD Projects) will be created for the selection of dedicated PWD projects. In case if any target remains unassigned/surrender/forfeited or selected top PIAs are unable to take on/ complete the targets, the PAC may select PIA next in ranking based on QA score and availability of training target.
  - c. Target Allocation to Category 'B' Agencies- Top 30 agencies (as per highest quality score) will be selected for allotment of training target Allocation to Category 'C' Agencies- Top 19 agencies (as per hest quality

    - If any targets are surrendered/ forfeited for a PIA in category B/C/D, it should be allocated to the other already selected PIAs in the same category first by the PAC.

If any targets remain unallocated in the same category due to any reason, the targets should be allocated to category B selected agencies first, and then category C selected agencies if they could not be allocated in category B and then category D, if they could not be allocated in category C

- If any training targets are still available even after following the procedure in the
  aforementioned point, then the remaining targets may be allotted to candidate
  agencies(apart from top 30 selected agencies)next in ranking based on QA score
  and availability of training targets, within the category B
- f. PAC shall have the right to amend any or all above conditions at any time depending on the need for successful completion of DDUGKY 2.0 target.

Note: The Project Approval Committee (PAC) of RSLDC shall have the final authority to make decisions regarding project approvals, based on budget availability, sector preferences, district coverage and number of candidates to be allocated. The decisions of the PAC shall be final and binding, and not subject to challenge. Those who are interested may apply through the portal <a href="https://kaushal.rural.gov.in">https://kaushal.rural.gov.in</a> within 21 calendar days after floating the Eol.
