Project duration should be of a maximum of One (1) year. As per the targets available with the state at present, PIA should submit the proposal for Three (3) and Six (6) months National Skill Qualification Framework (NSQF) aligned courses/Job Roles. PIAs are requested to submit their proposals on or before 31<sup>st</sup> May, 2025.

The State Project Approval Committee (PAC) is the final authority for sanctioning of the project on the basis of the merit of the proposal and DDU-GKY 2.0 guidelines and SOP. As per target assigned by the Ministry of Rural Development, preference will be given to PIAs with registered office and working experiences in the State of Sikkim. PIA having closed their DDU-GKY 1.0 project (100% training target achievement) with more than 60% placement will be preferred.
